# "Rates, Valuations, and Waters – times are changing."

The Waters include drinking water, wastewater and storm water.

The Government is currently focused on a "Local Water Done Well (LWDL)" approach, which involves councils taking the lead in delivering water services, with a focus on local decision-making and flexibility. This is a shift from the previous government's reforms which proposed creating larger water service entities. The current plan emphasizes council ownership and control of water services, while also addressing infrastructure challenges and financial sustainability.

Councils are required to develop and submit Water Services Delivery Plans, by September 2025, outlining their water infrastructure, investment needs, and delivery models. The Government will establish water service settings including economic regulation, service quality, infrastructure investment and climate change resilience.

Councils will need to demonstrate how they plan to deliver water services in a financially sustainable way. PNCC, Horowhenua and Rangitikei Councils are planning to establish a joint Council Owned Entity to implement the new water service from 2028.

PNCC is transitioning to a new rating system over three years, shifting from a system primarily based on land value to one that includes both land and capital value. This means a larger portion of rates will be based on the capital value of properties, including the value of buildings and improvements, in addition to the land value. Approximately 16.5% of the general rates are currently based on capital value, while the remaining portion is based on land value. The capital value component is scheduled to increase to 33% in 2025/26 and then to 50% in 2026/27. The overall level of rates will remain the same or increase annually but the way it is distributed will change to the new formula.


I will organise any speakers of particular interest to Awapuni to fall on their meetings. This is a good way to ensure PN Rotary gets to know and support Awapuni Rotary.

#### **Pre-Paid Business Membership**

The Board approved (June 2025) that if the Business pre-pays, then any Associate






